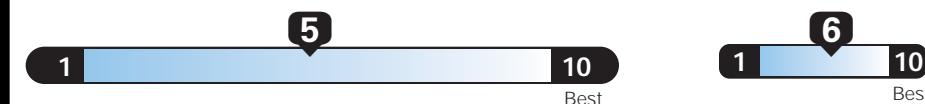

### Bumper Performance
